4. _____ It is agreed that the Society shall not authorize publication by others of the transcript or any part thereof, including brief quotations, during my lifetime without my express written permission.
5. _____ I retain all of my right, title, and interest in the tapes, transcripts and their content, including literary rights and copyrights, until _____ [state date or event], at which time these rights shall vest in the Historical Society of the District of Columbia Circuit.
