


Historical Society of the District of Columbia Circuit





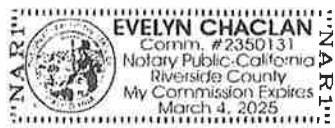
